The Affordable Housing Alliance (AHA) is an organization dedicated to making sure every New Jersey resident has the opportunity to live a better life. We do this by offering an array of services that are essential to creating a stable, sustainable, efficient, and healthier environment for our New Jersey residents. We pride ourselves on providing quality services meeting or exceeding all contracted goals within budget while working with a variety of state and federal agencies as well as stakeholders.

Over the last 27 years, AHA has only continued to grow. In 2018, we proudly: provided over 600 units of rental and supportive housing, helped create knowledgeable homeowners, preserved

home-ownership and sustain financial independence, provided utility assistance throughout NJ to support those who are falling behind on payments and housing placement.

We were also involved in the community; through our Community Action Programs we ensured those below the poverty line had the finest safety net services to secure and sustain independence. In the past year, we have: administered the largest state supported utility assistance program (PAGE), provided assistance to over 10,000 households, constructed 150 units of affordable family and special needs rental housing, supervised the management of the Financial Success Center funded by United Way, and was selected as the Lead Sandy Housing Counseling Agency for NJDCA serving 9 counties.

Looking toward the future, the AHA is looking to: define metrics, enhance evaluation, and pursue strategies that respond to the needs and support of the community. Our goals include serving an increased number of New Jersey residents with critical essential services, increasing administrative services for municipalities as they settle affordable housing agreements with Fair Share Housing, and continuing to develop affordable housing unique to the communities' individual needs.

We are constantly working to improve our communities and ensure that everyone in them has an equal opportunity for an affordable, safe and reliable place to call home.





HOUSING OUTREACH 2018 | HIGHLIGHTS



The Housing Outreach Services Department provides a multitude of services to meet the needs of the community including housing counseling, financial coaching, and administrative agent duties for various municipalities.

The Housing Counseling program is HUD-Certified and provides counseling for prepurchase, home ownership, foreclosure intervention, reverse mortgage and disaster recovery across ten experienced housing counselors on staff.

Financial coaching is offered to ALICE (asset-limited, income-constrained, employed) eligible households to assist them in reaching their financial goals.

The department serves as a Administrative Agent for the purchase and rental of Affordable units across many municipalities in Monmouth County to ensure qualified candidates can gain access to sustainable housing. The department also provides rental search assistance as well as resources & referral.

UTILITIES DEPARTMENT 2018 | HIGHLIGHTS



The Utilities Department at the AHA offers various energy assistance programs tailored to assist NJ residents that are struggling to pay their utility bills.

We are the designated agency to process LIHEAP/USF in Monmouth

County, which helps zero-to-low income local residents with assistance towards their gas, electric and/or deliverable fuel bill(s).

The AHA administers the Payment Assistance for Gas & Electric (PAGE) program, which is funded by the NJ Board of Public Utilities (BPU). PAGE is an annual assistance program designed to help working families across the state of New Jersey who are experiencing economic hardship and are struggling to pay their electric and/or natural gas bill(s), and whose income is above that for the Low Income Home Energy Program (LIHEAP) or the Universal Service Fund (USF).

The Utilities Department also processes applications for the Gift of Warmth and ACE Helping Hands programs, which are additional utility grants for qualified households and offered by New Jersey Natural Gas and Atlantic City Electric, respectively.







CAP (COMMUNITY ACTION PROGRAM) & EMERGENCY HOMELESS HOUSING SERVICES



Reduced homelessness in Monmouth County for 2018 by preventing ninety-six (96) households (286 participants) from being evicted and assisting sixty-two (62) households (163 participants) in securing housing through a grant for security deposits.



Through the affiliation with the food pantry and soup kitchen at St Marks in Keansburg, over thirty-seven thousand seven hundred and thirty-four (37,734) meals were served to homeless and low-income Monmouth County residents.



AHA-CAP works in partnership with SCAN to provide funding for their Digital Aging Mastery Program (DAMP). Eighteen (18) seniors attended monthly group sessions with both general health and technology training components.



Thirty-five seniors participated in the SCAN aging in place program. These seniors received valuable information and connections to services which are designed to allow them to remain in their homes with assistance as an alternative to entering assisted living facilities.



Forty seniors received assistance with managing brain health through a partnership between AHA-CAP, SCAN and St. Barnabas Health System.



Eighteen low-income adolescents participated in a 6-week Summer STEAM Program with free breakfast and lunch daily. Transportation to and from the camp was also provided.



Ten low-income adolescents were able to engage in a twelve week, full day, mentor-activity based summer program through Camp Zehnder. This program included free lunch and transportation for its participants along with daily skill building activities.



Beneficiaries of the EZ-Ride program receive a grant of up to \$1,000. During 2018, 24 riders were actively engaged in this program. They received 663 grant-funded rides to expand their access to employment at higher wages, safe affordable childcare, opportunities to expand their vocational training, in addition to greater access to other essential resources.



Twenty-four Monmouth County residents received transportation assistance in the form of taxi vouchers and utilized over six hundred and sixty-three rides to gain access to better employment, healthcare and other essential services.



One hundred and thirty-nine (139) homeless Monmouth residents received emergency housing services for up to thirty (30) days while gaining access to job placement assistance, transportation services, physical health services, and mental health assessments.

PROPERTY MANAGEMENT

The Affordable Housing Alliance (AHA) brings specific knowledge of the housing markets in which we operate and the understanding of the cultural and economic diversity within each of them.

The AHA has property management experience with multiple derestricted affordable housing funding sources, including: LIHTC, HOME funds, HUD 202 and the Federal Home Loan Bank, among others.

The Property Management team is continuously focused on becoming an industry leader in affordable housing management operations by: Increasing occupancy standards, reducing delinquency and collections, implementing faster vacant turn process to reduce vacancy rent loss, instituting policy and procedure manuals, maintaining the marketing of all portfolio units on a continued basis, participating in and passing all local, state and federal inspections and providing timely reporting as required by HUD guidelines.


